
ADMINISTRATIVE ORDER NO.
22-02 (AMENDED)

Judge Russ Kendig is retiring effective September 30, 2022. Starting October 1, 2022, Canton cases will be assigned to Judges John P. Gustafson, Tiiara N.A. Patton and Mary Ann Whipple.

During Judge Kendig's service, he entered Administrative Orders governing practice and procedure requirements in Canton. A list of Judge Kendig's Administrative Orders is attached. Effective October 1, 2022, all of Judge Kendig's Administrative Orders are terminated. Judge Kendig's terminated Administrative Orders remain accessible on the court's website under the Tab Judges' Info/Administrative Orders. The transition judges may enter any Administrative Order governing their case assignments in Canton as they deem appropriate.

During Judge Kendig's service, he posted Memoranda addressing various aspects of practice in Canton. Effective October 1, 2022, all of Judge Kendig's Memoranda are terminated, to the extent they did not already terminate by their terms. Judge Kendig's terminated Memoranda remain accessible on the court's website under the Tab Judges' Info/Memoranda. The transition judges may issue any Memoranda pertaining to their case assignments in Canton as they deem appropriate
